## Vineland, N.J. January 5th, 1882

Regular Encampment – of Lyon Post No. 10, G.A.R., Dept. of New Jersey, Wednesday, Evening – 7:30

Post opened in due form, with the commander in the chair.

**Officers absent** – at roll call – Q.M., O.D., O.G. & Q.M.S. **Comrades filled vacancies as follows** –Babcock, Parsons, Wanser and Pasco.

**Minutes** – of the last regular encampment were read and approved.

General Orders – No. 12 – Nat. H.Q. and Dept. H.Q. orders No.'s 15 & 16, were read and ordered filed.

- **Committee** on application of W.W. Whiting to become a member of the post. Committee consisted of Comrades Parson, Capen and Singleton, which reported favorably, on motion, report was accepted. ballot be taken, W.W. Whiting was duly elected.
  - **O.D. Reported** that the candidate was in waiting at the out post and presented to orders of the P.C., was Admitted and duly mustered in the ranks of Lyon Post No. 10, Dept. of NJ, G.A.R.
- **Relief Committee** Comrade Conly (of \_\_\_?\_\_ Post, Dept of Pa.) so far improved that he would need no further assistance beyond an order to be drawn tonight.

Comrade Hamilton – reported change of residence to Landis Ave above 7<sup>th</sup> St.

- **On Motion** an order be drawn on the Q.M. in favor of Com. R.S. Conley of Gerble Post, Dept. of Pa. For \$8.00 for two weeks of sick benefits. Carried.
- **On Motion** the adjutant was instructed to inform Gerble Post that Comrade Conley was off the sick rolls, and to Draw on the post for the amount of \$16.00 four weeks benefits paid the comrade. Carried.
- **The Resignation** of our Junior vice elect, Com. J.A. Strong (reason having gone to Florida). The P.C. ordered A new election to fill the vacancy. Comrades Parsons and White appointed a tellers. The post then proceeded to nominate, the ballot being taken resulting in the election of Comrade Wanser for Junior Vice commander for the ensuing year.
- **The name of** John Montgomery (with the fee of \$1.00) was presented, balloted for and elected to membership in the contributing corps of this post.

**Comrade C.P. Lord** – representative of the department as installing officer being present – The P.C. informed him that we were now ready to proceed to install the officers for the ensuing year.

## Our installation - ceremony was broken in upon -

by a little matter which should not be overlooked and what at one time had the appearance of meaning (?) the harmony of the evening and the beauty of our installation (to one of our comrades at least)

It was at that past, when our retiring commander, his adjutant and Quarter master are ordered to the front to answer the necessary questions which they did satisfactory, the adjutant and Q.M. were dismissed. Motion made – by Comrade Wanser that Com. Lord's services be secured.

- **On Motion** Com. Greene suggested that a committee be appointed to secure a hall and arrange for entertainment. Comrades Greene, Parsons and Wanser were appointed to said committee.
- **O.D. Ross** stated that E.B. Shaw wished to be reinstated in full membership in this post and wished to know what would be the entire cost to do so.

On Motion - E.B. Shaw be reinstated on payment of \$2.50. Carried.

**Camp Fire** – Committee reported progress.

There being no further business the post closed in F. C. & L.
